Lyophilized Powder Delivery Form: Pre-lyophilization buffer is Tris/PBS-based buffer containing 6% Trehalose.

4. Storage Conditions

Upon receipt, store the product at -20°C or -80°C. It is recommended to aliquot the

protein for multiple uses to avoid repeated freeze-thaw cycles, which may cause protein denaturation and activity loss.

5. Product Description

This product is a recombinant Human YWHAB full length protein (1-246aa) expressed in E.coli. The protein is with GST tag at the N-terminus, which facilitates protein purification, detection and identification. YWHAB, also known as HS1 or GW128 or YWHAA, is suitable for related in vitro functional assays, protein interaction studies, antibody preparation and other biomedical research applications.
